A number corresponding to name must be placed on plat to identify grave.

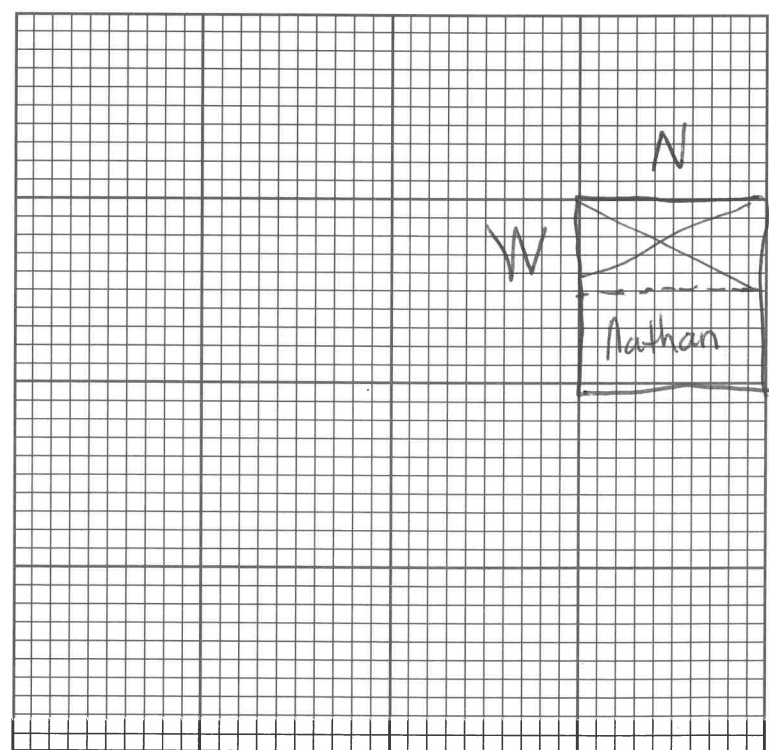
