## Field Record of Previous Burials

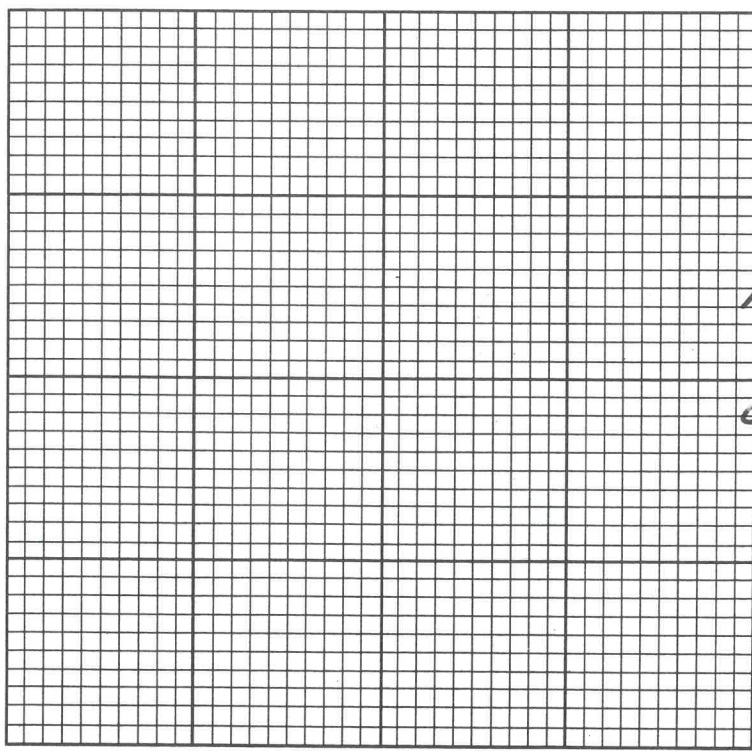
*These sheets to be used on the grounds to secure data which will be copied permanently in Cemetery Lot Record.*

NOTE: Each small square represents a square foot of lot surface. For convenience each tenth foot is indicated by a heavy line. To make a record of previous burials, draw a diagram, with pencil, of each lot, beginning with Lot No. 1, and use a separate sheet for each lot. This can be done in the office from the plat and the owner's name and other data as to ownership secured from deed records. These blanks will then be taken to the cemetery and a record will be made from the lists of the names of those buried and location of grave on lot. A number corresponding to name must be placed on plat to identify grave.
