*These sheets to be used on the grounds to secure data which will be copied permanently in Cemetery Lot Record*

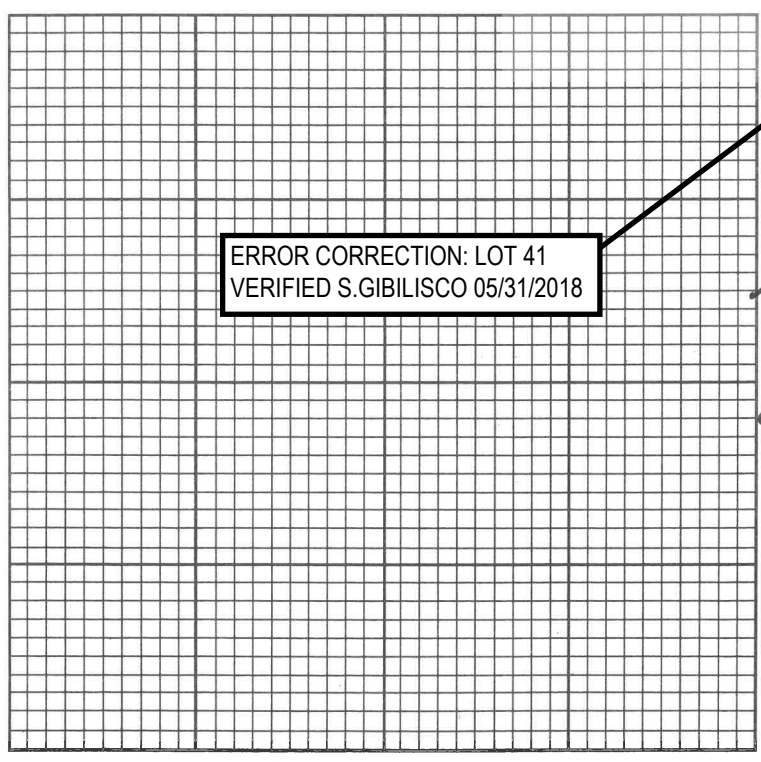

These blanks will then be taken to the cemetery and a record will be made from the plats, of the names of those buried and location of grave on lot. A number corresponding to name must be placed on plat to identify grave.
