These sheets to be used on the grounds to secure data which will be copied permanently in Cemetery Lot Record.

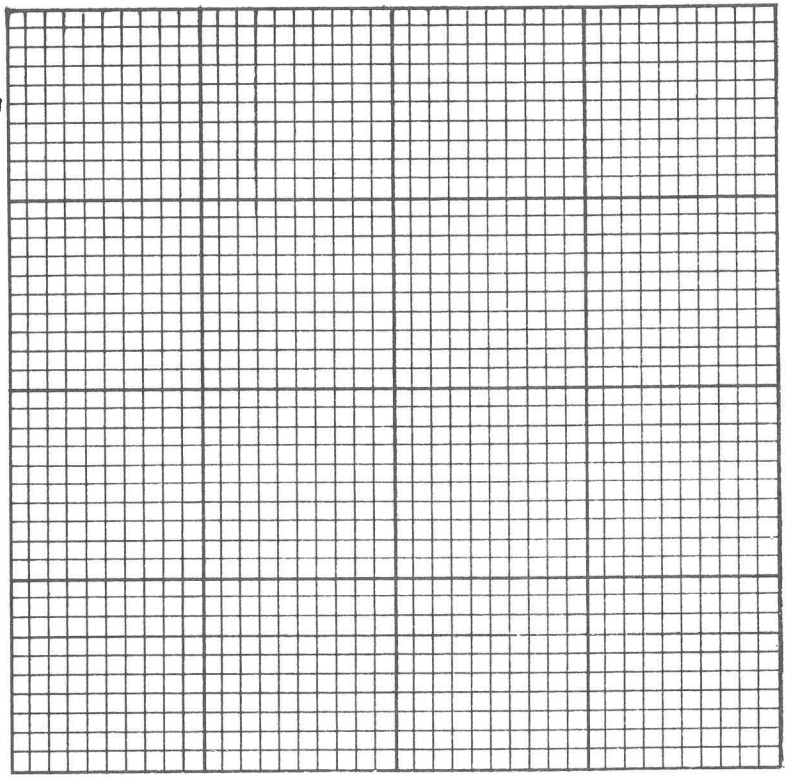

A number corresponding to name must be placed on plat to identify grave.
