**Field Record of Previous Burials**

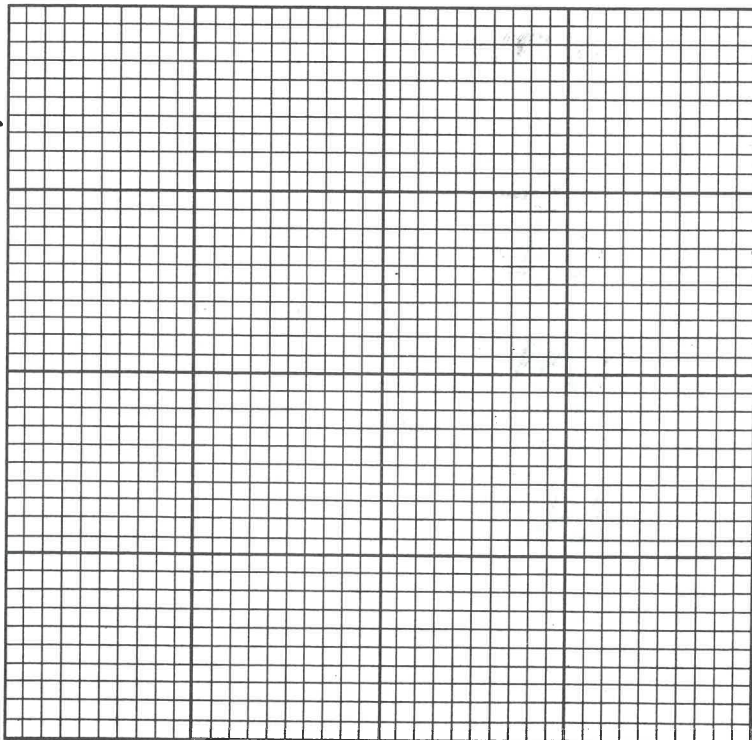
*These sheets to be used on the grounds to secure data which will be copied permanently in Cemetery Lot Record.*
