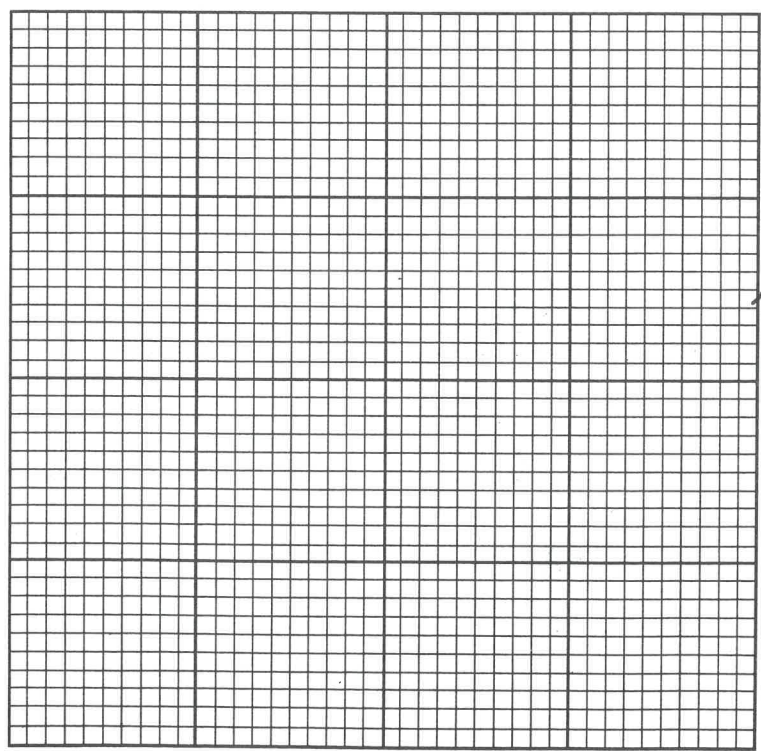
**Field Record of Previous Burials**

These blanks will then be taken to the cemetery and a record will be made from the lots, of the names of those buried and location of grave on lot.
