Donna Raye Maxine, daughter of Raymond John and Helen Marie (Sears) Green was born September 22, 1941 in Nebraska City, Nebraska. She passed away on February 17, 2014 in Glenwood, Iowa at the age 72 years, 4 months and 26 days.

Donna was raised in Brock, Nebraska where she attended the Brock Community Schools, graduating from Brock High School with the Class of 1960. She attended the University of Nebraska-Lincoln for one year before deciding on a nursing career. She studied and worked at Lincoln General Hospital, receiving her Diploma in Nursing in 1964.

In 1965, Donna was united in marriage to William E. Shaw in Nebraska City, NE and to this union three children were born, George Eric Shaw, Montgomery Daniel Shaw and Susan Raye Shaw. Donna was also a member of the Shenandoah Congregational Church for many years, later becoming a member of the First Christian Church in Shenandoah. She enjoyed quilting, scrap booking and making her own greeting cards.
